

Corrosion Technician

Wolverine Pipe Line Company is a transportation service company, headquartered in Portage, Michigan and incorporated in 1952. We have over 85 employees in the three states we operate in – Michigan, Indiana, and Illinois. Wolverine operates 700+ miles of active steel pipeline, connecting Chicago refineries to terminals in Michigan and Northwest Indiana and moving product west to east. We transport over 350,000 barrels or 14.7 million gallons of refined products a day. Wolverine also provides approximately 30% of Michigan's daily refined products supply. We deliver the products that fuel the nation.

Wolverine does not own the product we ship. We are strictly a transport vehicle for our customers, much like UPS or FedEx is for packages. The Federal Government regulates the tariffs Wolverine charges to transport products between origins and destinations.

Summary of Duties and Responsibilities:

Responsible for planning and overseeing corrosion related work including occasional oversight of contract resources. Responsible for completing corrosion related tasks to ensure regulatory compliance as well as company specific Integrity Management requirements. The role is also responsible for managing a variety of tasks related to data acquisition and interpretation, testing, troubleshooting, installing, and maintaining all elements of the corrosion control system.

Essential Duties and Responsibilities: (Not all inclusive)

- Conduct all regulatory and company required corrosion control inspections in a technically sound, efficient
 manner. Routine Inspections include but are not limited to: Annual Cathodic Protection Survey,
 Atmospheric Corrosion Inspections, Bi-Monthly Rectifier and Critical Bond Inspections
- Proactively identify potential corrosion related issues and implement corrective actions
- Monitor and maintain all elements of the corrosion control system
- Communicate effectively with Supervisor, other Wolverine employees, contractors, and foreign operators on all aspects of the job requirements
- Effectively prioritize and manage multiple projects with minimal supervision
- Embrace and champion all safety policies and procedures according to Wolverine's safety program and or industry standards or requirements
- Collection and analysis of data to determine the most technically effective and cost-efficient means of protecting assets from corrosion
- Supports development and stewardship of the long-term planning for the corrosion program and its annual budget
- Assist in design reviews and specify requirements and recommendations for safeguarding Wolverine's assets utilizing sound corrosion principles

- Assurance that the design of corrosion control installations and methods are technically sound and in line with industry standards and practices
- Perform repairs or replacements of corrosion control elements in a safe and technically sound manner
- Identification and prioritization of specific projects, developing scope of work, soliciting bids and execution of corrosion control projects
- Technical and supervisorial oversight of contractors performing corrosion related work.
- Maintenance of Wolverine's written corrosion control policies and procedures manuals (FIMMS)
- Record retention according to regulatory and Wolverine policies
- Works closely with Integrity Management Program personnel on integration and comparison of In-Line Inspection data with corrosion control data
- Attend training events and conferences to obtain and maintain certifications
- Regular attendance and regular attendance at quarterly Corrosions Interference committee meetings

Education, Prior Work Experience and Specialized Skills and Knowledge:

- A minimum of 3 years' experience working on PHMSA regulated pipelines
- High School diploma (required), associate's degree or greater is a plus
- Valid driver's license and a good driving history
- Excellent time management, organizational and communication skills
- Self-motivated and self-disciplined; must be able to work independently and with minimal supervision
- Ability to work effectively in a team environment
- Proficiency with MS Office Suite of applications
- Working knowledge of DOT CFR Title 49, Part 195 as it relates to corrosion control
- Proficiency with Cathodic Protection Data Manager (CPDM) software, or can learn within the first 6 months
- Must either have an AMPP/NACE CP1 certification or obtain the certification within the first 6 months

Physical Environment/ Working Conditions:

- Frequently works in a normal office and/or field environment
- Ability to frequently lift and carry 50 lbs. for a minimum of 50 feet
- Frequent sitting, climbing stairs, standing, walking, kneeling, stooping, bending, and crouching
- Frequently reaching for and gripping objects.
- Frequent physical labor
- Frequent work in various locations, both indoors and outdoors, in a variety of weather conditions, temperatures and terrains
